ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

- The Offer Price has been determined to be HK\$0.45 per Offer Share plus brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%.
- Based on the Offer Price of HK\$0.45 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other related listing expenses payable by the Company in the Share Offer, is estimated to be approximately HK\$65.9 million. - A total of 19,383 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms for a total of 36,321,720,000 Public Offer Shares, equivalent to approximately 1,816.09 times of the total number of 20,000,000 Public Offer Shares initially available under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the re-allocation procedures as described in the section headed “Structure and Conditions of the Share Offer — Re-allocation between the Placing and the Public Offer” in the Prospectus have been applied. Based on the Offer Price of HK\$0.45 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other related listing expenses payable by the Company in the Share Offer, is estimated to be approximately HK\$65.9 million. - approximately 90.8%, or approximately HK\$59.8 million, of the net proceeds to be used for expediting the organic growth and expanding the business scale by undertaking more and larger sized fitting-out and alteration and addition projects in Hong Kong and Macau.
